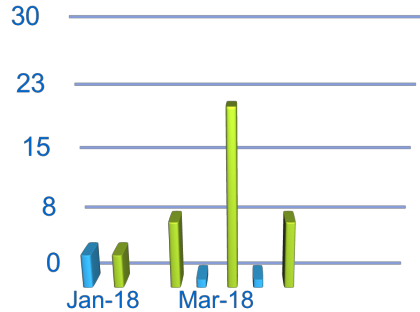

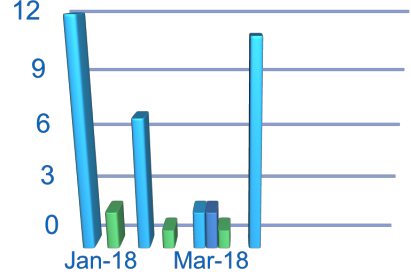

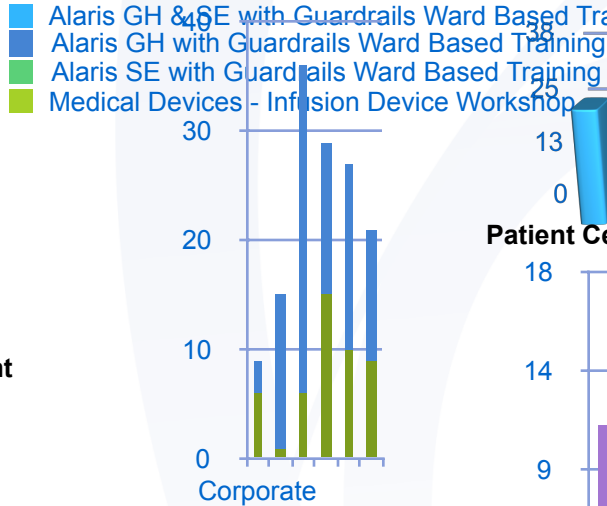
## Alaris SE and GH Training



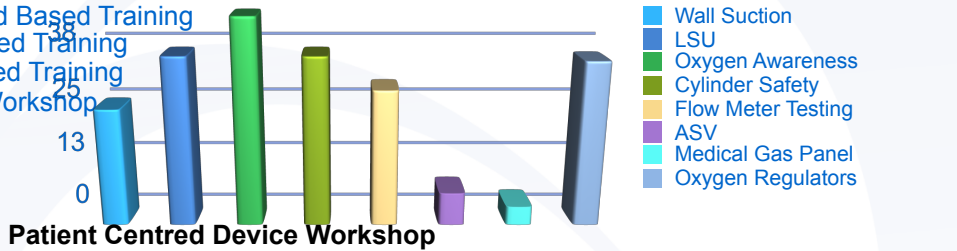
## Alaris SE and GH Assessment



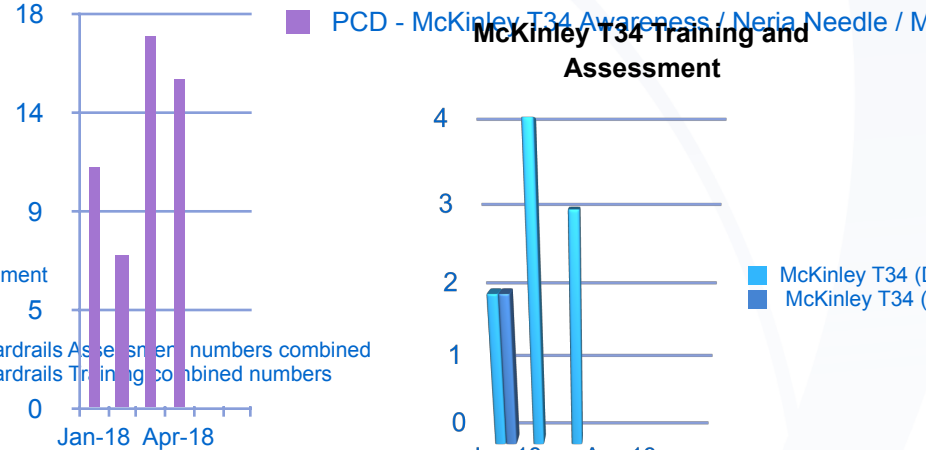

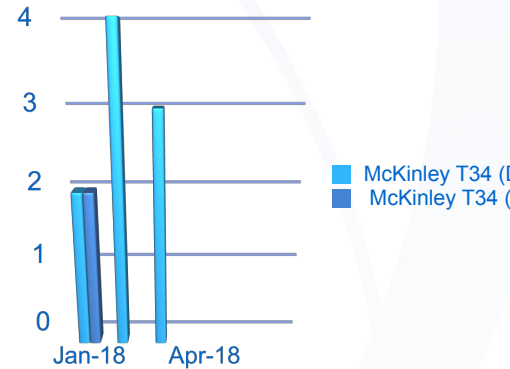

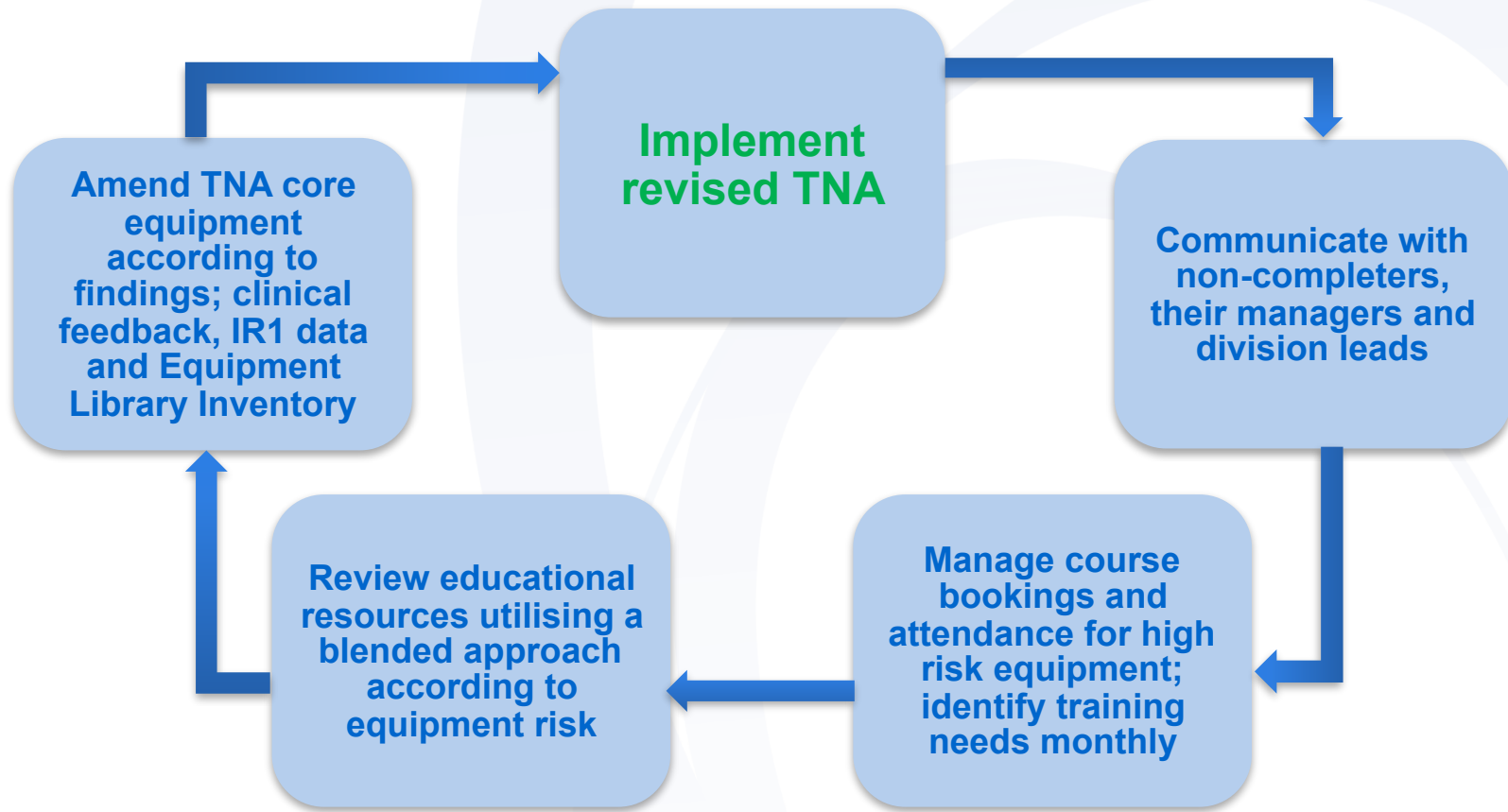
